On the cover: Graphical representations of MHC class I molecules H-2D<sup>b</sup> and HLA-A2.1. Identical residues are shown in green. A murine CTL clone (AHI112.2) displays peptide-specific recognition of both of these molecules, and cytolytic assays suggest that these are functionally equivalent epitopes. This TCR appears to make a different, but overlapping, set of contacts with each class I/peptide complex.
