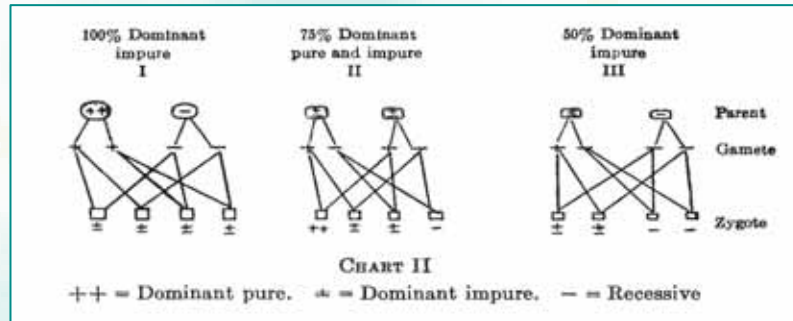

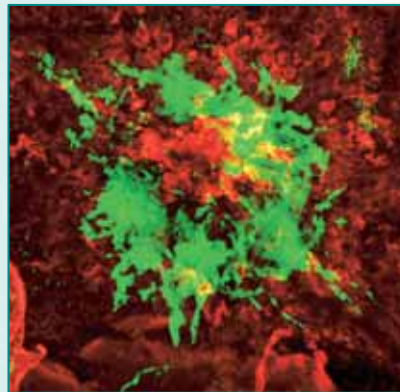

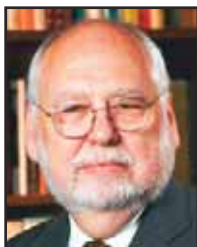
The American Association of Immunologists congratulates the following distinguished members on their selection as AAI Award Recipients for 2008.
